The City of Melissa, Texas is accepting sealed bids for construction of:  
**Throckmorton Road from SH 5 to CR 418**

The project is generally described as: **Construction of approximately 5,500 linear feet of Throckmorton Road between SH 5 and CR 418 with curb and gutter, drainage, and utility improvements.** for the City of Melissa, Texas as shown in plans prepared by Kimley-Horn and Associates, Inc., TBPE Firm No. 928.

All bids received prior to the closing of the bid period will be publicly opened and read aloud at the City of Melissa City Hall, 3411 Barker Avenue, Melissa, Texas 75454 beginning at 2:05 PM on March 21, 2017. Following bid opening, tabulation will be made for consideration of the City of Melissa in awarding a contract. **Contractors participating in bidding are encouraged to attend an optional Pre-Bid meeting scheduled at 2:00 PM on March 14, 2017 at the City of Melissa City Hall.**

No officer or employee of the City of Melissa shall have a financial interest, direct or indirect, in any contract with the City of Melissa.
