

11. South 88 degrees 06 minutes 42 seconds East, a distance of 78.49 feet to a point within Melissa Road;
12. South 01 degrees 20 minutes 34 seconds West, a distance of 1,421.94 feet to a 1/2 inch rebar found;
13. South 01 degrees 22 minutes 11 seconds West, a distance of 887.06 feet, returning to the **POINT OF BEGINNING** and enclosing 13.013 acres (566,856 square feet) of land, more or less.


